

Comunicarea identităților transnaționale

Cursul se adresează studenților de anul II masterat și se focalizează pe înțelegerea noii forme de comunități și identități din diasporă, prin migrație spre transnaționalism, pentru a arăta legătura profundă dintre migranți, limbi, media, patrie și țara gazdă pentru a aborda întrebări precum "Ce înseamnă acasă în lumea contemporană și în Europa contemporană"?

Cursul este o abordare interdisciplinară a fenomenului diasporei și comunităților transnaționale, mobilizarea politică și paradigma politică a deconstrucției și reconstrucției statului. Studenții vor fi obișnuiți să discute analiza, discursul media, discursul politic.

Va fi introdus studiul prejudecăților și stereotipurilor privind migranții, refugiații etc. Legați și respinși simultan de două țări, diasporanii dezvoltă loialități multiple care exprimă noi modele de homing, prezentând un comunitar stratificat, cu grade de integrare foarte diferite. Escapismul utilizării limbii materne ca refugiu final chiar și în mass-media (online), fără a înceta să se raporteze la alții semnificativi, subliniază o relație de ură-dragoste cu patria și gazda, stimulată de auto-stigmatizare, în încercarea de a redefini identitățile în o călătorie lungă către un loc de pierdere și nostalgie, unde ceva lipsește întotdeauna pentru nevoia de a fi acceptat ca "europenii".
